#### 2. Discussion: Capital Campaign fundraising

Library needs someone to take the lead with fundraising. It's important to get information from other fundraising consultants and library needs to hire someone for the duration of the campaign. We have proposals, will need someone to work with us to fundraise and a committee of workers.

Fund balances to date are \$650,000 from the Foundation, approximately \$225,000 in donations, \$500,000 in appropriations grant, and potential \$200,000 from local foundation. The space itself is a gift of over \$4,000,000.

Previous efforts did not have a formal capital campaign committee, and now the board should establish a working committee as well as get involved. It is up to the board to hire a fundraiser. The campaign also need a "celebrity" chair or co-chair.

Fundraising firms should be interviewed, and the library owes it to ourselves to hire the best organization to do this. Whoever is hired needs to be able to organize and work with us, get us to

follow through with tasks, and provide a uniform, consistent message. Whoever is selected should be local.

Action to be taken at next meeting will establish a fundraising committee to solicit proposals for consulting services.
